## Indifi E&S Exclusion List

Indifi shall not finance the items listed below:

- 1. Production of, or trade in, any product or activity deemed illegal under applicable local or national laws or regulations or subject to internationally agreed phase-outs or bans as defined in global conventions and agreements such as certain:
  - a) hazardous chemicals, pharmaceuticals, pesticides and wastes
  - b) ozone depleting substances
  - c) endangered or protected wildlife or wildlife products
  - d) unsustainable fishing methods such as blast fishing and drift net fishing in the marine environment using nets in excess of 2.5 kilometers in length
- 2. Production of, or trade in, arms (i.e. weapons, munitions or nuclear products, primarily designated for military purposes);
- 3. Production of, use of, or trade in, unbonded asbestos fibres;
- 4. Production of, or trade in, radioactive materials [*This does not apply to the purchase of medical equipment, quality control (measurement) equipment and any equipment in which the radioactive source could reasonably be trivial or adequately shielded*]; or
- 5. Prostitution.
- 6. Any activities involving forced labour<sup>1</sup> or child labour<sup>2</sup>
- 7. Any businesses, if any of the following activities represents a substantial portion of such business [for financial institutions, "substantial" means more than 10% of their underlying portfolio volumes]
  - a) Gambling, gaming casinos and equivalent enterprises;
  - b) Tobacco or tobacco related products [except, in the case of tobacco production only, with an appropriate timeframe for phase out]; or
  - c) Pornography;
  - d) Alcoholic Beverages (excluding beer and wine).
- 8. **Coal**
- a) Coal-fired power plants, including dual-power plants.
- b) Refurbishment, retrofitting and rehabilitation of existing coal power facilities, including dual-power plants.
- c) Coal prospecting, exploration, mining, processing and trading.
- 9. **Oil** 
  - a) Upstream oil exploration and production.

- b) Midstream oil, including pipelines.
- c) Downstream oil, including refineries and petrol stations.
- d) Heavy fuel oil (HFO) or diesel-only, dual-fuel HFO or diesel/gas and HFO or diesel/renewable hybrid power plants.
- e) Refurbishment, retrofitting and rehabilitation of existing4 HFO or diesel-only, dualfuel HFO or diesel/gas and HFO or diesel/renewable power plants leading to an increase of absolute GHG emissions (i.e. where energy efficiency measures do not compensate for any capacity or load factor increase) and/or where the lifetime of an asset that would be otherwise retired would be substantially increased.
- f) Diesel-only mini grids.

## 10. Gas

- a) Upstream gas exploration and production.
- b) Midstream/downstream gas (including gas import/export infrastructure and processing facilities) except gas transport, storage and distribution infrastructure where the primary purpose is power generation consistent with a country's pathway to net zero emissions by 2050 or liquid petroleum gas (LPG) and associated facilities for sourcing, transport, storage, bottling and distribution. Transport
- c) Transport (road/rail/port) infrastructure where the primary use is fossil fuel transport
